At a regular meeting of the Planning Commission, held on July 7, 2020 at 7:00 P.M. in the King William Administration Building Board Room, the meeting was called to order with the following members:

Agenda Item 3. Review and Adoption of Meeting Agenda

Chairman, Don Wagner requested a motion to adopt the July 7, 2020 meeting agenda. Ms. Janie Rhoads made a motion and the motion was seconded by Mr. Stephen Greenwood.

The vote was unanimous on this motion.

Agenda Item 4. Review and Approval of Minutes

Chairman, Don Wagner requested a motion to approve the June 2, 2020 meeting minutes. Mr. John Breeden made a motion to approve the minutes as submitted and Ms. Janie Rhoads seconded the motion.

The vote was unanimous on this motion.

Agenda Item 5. Public Comment Period

There being no one to speak the Public Comment Period was opened and closed by Chairman, Don Wagner.

Agenda Item 6. Public Hearings

A public hearing for CUP-02-20 was held to consider the request of Todd Shoaf and Kelly Tait to construct a 24 x 56.6’ attached accessory dwelling on their property located at 6585 Mt. Olive Cohoke Road, Tax Map Parcel 53-1-1. Following much discussion, the Public Hearing for CUP-02-20 was closed by Chairman, Don Wagner.

Mr. Stephen Greenwood made a motion to approve the Conditional Use Permit, with the condition that the accessory dwelling shall be occupied by immediate family only, and Mr. John Breeden seconded the motion.

Agenda Item 7. Old Business

Members and Staff discussed ordinance updates and Mr. Ron Etter informed the Commission that the draft was sent out to approximately twenty stakeholders, the sheriff and animal control. Mr. Etter requested that all comments be received no later than July 31, 2020.

Chairman, Don Wagner requested that when we are in the forum to show any changes, that he would like to see a crossover with the current and proposed changes, to match them up.

Agenda Item 8. New Business

Chairman, Don Wagner commented in regards to 86-60 Adult Entertainment being removed from the ordinance without a proper vote from the Commission. Chairman Wagner requested a

motion to remove 'adult entertainment' from the ordinance. Mr. John Breeden made a motion and the motion was seconded by Ms. Janie Rhoads.

The vote was 5-0.

Chairman, Wagner expressed his concerns on the Transportation Corridor Overlay District, as far as buffers needing to be required for construction sites to preserve vegetation for close by residences, as well as the materials used for buildings in that district. Chairman, Wagner was also curious if the Mini Storage would be climate controlled, as he did not see insulation being installed.

Mr. John Breeden requested that the ordinance be checked to see if coated metal has been addressed.

Chairman, Wagner also stated that he would like to require any construction project in the TCO to come before the Planning Commission.

Chairman, Wagner voiced his concerns on parcel 22-39 of Route 360, as it is not in compliance with the Transportation Corridor Overlay District section of the ordinance. He stated that he would like Commission and staff to work together to require and enforce the needed improvements for that corridor.

Mr. John Breeden noted to the Commission that if the ordinance is still not up to standards, then there is still time to make changes.

Agenda Item 9. Staff and Special Committee Reports

Mr. John Breeden gave an update on the Solar Subcommittee, as well as provided a report for members and staff. He requested that the Commission members review the draft and submit comments to him before the next meeting.

Mr. Ron Etter gave an update on the Comprehensive Plan RFP and will be send out for bids. A panel is needed to review the firms and Mr. Etter requested that a member of the Planning Commission and Economic Development Authority to sit on the panel. Mr. John Breeden

expressed interest in sitting on the panel, therefore it was the consensus of the Planning Commission that Mr. Breeden represent them.

Mr. Ron Etter gave a brief update on the Kondakor property and informed the Commission that he would be visiting the site on July 13, 2020.

Several Planning Commission members stated that they would like the violation log made a part of the monthly packets.

Agenda Item 10. Adjournment

Chairman, Don Wagner requested a motion to adjourn. A motion was made by Mr. John Breeden to adjourn the meeting, and was seconded by Ms. Bonnie Hite. The meeting adjourned at 8:35PM.




